ABOUT FISHING IN MEXICO

Every vessel in Mexican waters carrying fishing gear, must obtain a sports fishing license for each person on board the vessel.

A sports license is not required for fishing from shore.

Anglers in ocean waters may use as many fishing rods/reels at the same time as desired. In inland waters, only one rod/reel may be used at any one time per fisherman. In both instances, the catch limits dictated by law must be observed.

A sportfishing license allows the angler to catch fish only; shellfish or crustaceans are strictly prohibited, the only exception is squid. Also totoaba, turtles, marine mammals, reptiles and amphibians are protected by federal law and must be avoided.

For bottom fishing, only up to four hooks may be used in a vertical line.

Electric powered reels may be used by persons with disabilities, and a special permit must be obtained from the authorities.

CATCH LIMITS:

- In ocean waters and estuaries, up to TEN FISH, with a maximum of five fish of the same species.
- Marlin, Sailfish, Swordfish, Shark, and Pescada (*Sterolepis Gigas*), the limit is ONE total— which will count as five of the same species.
- Dorado, Rooster Fish or Sabalo, Berry (*Mycteroperca Jordani*) or Bluefin Tuna (*Thunnus Orientalis*), the limit is TWO total — which will count as five of the same species.
- Squid. The limit is FIVE per angler per day
- Inland, fresh water. The total limit is FIVE fish either of the same or different species.
- Underwater fishing. Only when free diving — no tank, and using a harpoon equipped with rubber band, coil or pneumatic.
- Catch and Release. There is no limit as long as the catch is released in good condition for survival.
- Three days or longer — fishing from a vessel. The accumulated maximum number of catches per angler will be three times the daily limit as mentioned above.

Fonmar's website www.sportfishingbcs.gob.mx, is a secure and easy way to obtain your permit to fish in Mexico. All you need to do is enter your name(s), license term and start date and you will be directed to a secure banking site to add your credit card information — once the transaction is complete you'll receive an email confirmation and receipt, and a popup with the link to download and print your permits.

FONMAR also promotes Sport Fishing on local, national and international levels and provides funding for research and education at authorized academic and scientific centers to assist in the preservation of our oceans.

GET TO KNOW WHO'S WHO



The Maritime Authority works through MARINA (*Secretariat of the Navy*), to oversee compliance of the regulations issued by the IMO, in order to guarantee protected, efficient and safe maritime passages.



Provides Banking and Credit services to members of the Army, Air Force and Navy, and the General Public, and oversees the online services allowing payments for the temporary import of vehicles and boats.



An arm of the Mexican government which controls and supervises migration in the country.



The Mexican tax authority responsible for the supervision for compliance of tax and customs legislation.



The Mexican Navy is one of the two independent armed forces of Mexico. The naval forces are called the Armada de México. The Secretaría de Marina (MARINA) (*Secretariat of the Navy*) includes both the Armada and ministerial and civil service.



CONAPESCA is a decentralized body of SADER (*Ministry of Agriculture*) committed to legality, quality and transparency, in charge of fostering and developing coordination with various entities to implement policies, programs and regulations that lead and facilitate the development – competitive and sustainable, of the fishing and aquaculture sector of the country.



CONANP is the institution responsible for safeguarding the areas with the greatest biodiversity in Mexico.

HEALTH INSPECTION

The International Health Department in Mexico (*Sanidad Internacional*), is a governmental office operating according to the International Health Regulations (*IHR, 2005*), in order to “Control, Prevent, and protect against, the international spread of disease, and to provide a public health response that is commensurate with and restricted to public health risks, while preventing unnecessary interference with international trade and traffic”.

In most ports of entry in Mexico, health authorities don't impose any restrictions other than carrying out a medical inspection on arrival at no cost. Vaccine restrictions for COVID-19, do not apply in Mexico's ports of entry. Although some ports of call have different requirements by local health authorities, as such, during the medical inspection, they may ask for the Boat Registration, Personal ID, and Vaccination Record although this last item is not mandatory.

SEARCH AND RESCUE (SAR) OF THE MEXICAN NAVY

WHAT TO DO IN CASE OF EMERGENCY

If the boat is in a serious and imminent danger situation, you must send the distress signal: Mayday, Mayday, Mayday through VHF channel 16 or 2.182 KHz medium wave frequency. It is mandatory to have a VHF radio in minor boats. In order to receive a quick response, it is essential to have a 406 MHz Emergency Position Indicating Radio Beacon station (EPIRB) on board.

IMMIGRATION



The Instituto Nacional de Migración (National Immigration Institute) is the government arm required by Mexican

Law to oversee foreign individuals

visiting Mexico. Immigration clears in those individuals wanting to visit Mexico by boat and wishing to engage in recreational activities, including sport fishing, whale watching, diving and cruising — among others

IMMIGRATION REQUIREMENTS WHICH MUST BE PROCESSED AT THE FIRST PORT OF ENTRY IN MEXICO BY INDIVIDUALS CRUISING MEXICAN TERRITORIAL WATERS.

PLEASE NOTE: Now, when you arrive in Mexico by boat, you will not get a paper visa as before (known as the FMM entry form) — instead your passport will be stamped as proof and date of entry.

Passport/Visa

- ALL foreigners traveling to Mexico, including U.S. citizens, are required to carry a valid and current passport to enter Mexico. Non-Mexicans from certain countries may also require a Visa. Contact a Mexican Consulate for a list of these countries or:

A Passport **Book** allows U.S. Citizens to travel to/from Mexico using any means of transportation.

- **When arriving at your first Mexican port of entry** you will need to check-in at the local immigration office and each crew member must present his/her passport and will need to fill out an entry permit, and pay \$861.00 Mexican Pesos per person at the bank.
- The length of the stay will be the amount of time requested by the applicant, but shall not exceed 180 days, and cannot be used for multiple entries and departures.

A Passport **Card** allows U.S. Citizens to enter Mexico territorial waters by boat e.g. on a sports fishing trip, and then return to the United states. WITHOUT going ashore in Mexico.



FOLLOWING ARE THE IMMIGRATION REQUIREMENTS FOR INDIVIDUALS & VESSELS WHO WILL NOT GO ASHORE WHILE IN MEXICAN TERRITORIAL WATERS. THESE STEPS MUST BE PROCESSED PRIOR TO ENTERING MEXICAN WATERS FOR ANY LENGTH OF TIME. e.g. visiting the Coronado Islands, fishing ventures, offshore cruising, etc.

There are three steps to complete the FMM process.

1. Complete the INM process on the INM web portal (this includes payment).
2. Complete a spreadsheet with vessel and passenger information and email it to INM.
3. E-mail the spreadsheet and payment receipt to INAMI. Print a copy of the receipt and electronic manifest, and present to Mexican Navy if inspected.

Step 1 - Complete INM Process

The INM Process consists on five parts: Creating an INM account, registering travel document (Passport), registering vessel, registering trip itinerary and paying fees — a \$861 Mexican Pesos fee per each visiting foreigner as required by the Federal Fee Act (Ley Federal de Derechos), Article 8, Section I. The fee must be paid using a credit card.

You will need:

1. Passport (from vessel operator/representative)
2. Vessel documentation (State or Federal Registration)
3. Credit card (cardholder must match vessel operator/representative)

Start INM Process.

Follow instructions and download a receipt copy, as it will be needed in Step-3. Print an additional copy to keep aboard the vessel.

NOTE: The ACCOUNT you create will stay in the system. When you log in next time with your password and e-mail, the information you originally entered (e.g. vessel info and Passport) will be available by going to the FMM guide and choosing step 7 and select your "preregistered Vessel and Passport information".

Step 2 - Complete Electronic Manifest

Required information and documents to complete this form:

1. Full name and passport information of all crew and passengers.
 2. Vessel documentation (State or Federal Registration).
 3. Trip destination and itinerary.

Required information and documents to complete this form:

1. Full name and passport information of all crew and passengers.
2. Vessel documentation (State or Federal Registration).
3. Trip destination and itinerary. Click on the bottom left tab that says "data" and fill in the information for your trip.

Step 3 - Email Manifest and Payment Receipt to INM

A copy of the spreadsheet and payment receipt should be emailed to INM.

When visiting Coronado, emails should be sent to the Ensenada office:
BC_ensenada@inami.gob.mx

Applicants will receive an email from INM either authorizing the trip or denying entry. The email will contain INM's authorization to enter as "visitor without permission to perform paid activities". The length of stay will cover the amount of time requested in the application (shall not exceed 180 days). This is a one trip document and not intended for multiple entries.

Keep a copy of the receipt, the manifest, and your passports on board the vessel.

VESSEL DOCUMENTATION REQUIREMENTS

- Every vessel entering Mexico must carry ORIGINAL current Vessel Documentation or Registration that proves ownership; this means Federally Documented vessels will need to present a USCG Certificate of Documentation and undocumented vessels will need to have a valid State Registration. Foreign flag vessels from Canada, Australia, United Kingdom, British Virgin Islands, Cayman Islands, Republic of Marshall Islands, Japan, etc., will require a current Certificate of Registry.
- All vessels registered under a Corporation or LLC or when the legal owner is not on board, are required to have an original notarized letter onboard authorizing the Master or Representative to operate the vessel.
- Boat Captain or Master must present proof of competency for recreational boaters (example: Captains License, State Boating Card or International Certificate for Operators of Pleasure Craft (ICC)

TEMPORARY IMPORT PERMIT FOR VESSELS (TIP)

All vessels larger than 4.5m (15ft) are required to have a Temporary Import Permit (TIP) when in Mexico. The ORIGINAL TIP must be on board the vessel at all times. If your vessel has a Dinghy/tender, motorcycle, ATV, any motorized land vehicle, Helicopter, PWC Jet ski or WaveRunner remember that it must be included on the Import Permit in order to comply with Mexican Law.

If the vessel does not have a Temporary Import Permit "TIP" on board, or fails to exit Mexico prior to it's expiration, the vessel will be considered to be in Mexican territory illegally and may be subject to fines and/or confiscation by Customs Authorities.

Required documents as proof of ownership: Vessel documentation / Registration or Invoice, and Bill of Sale

VALIDITY OF A TIP

A TIP is valid for a period of 10 years from the issue date, allowing for multiple entries during this period.

A new Temporary Import Permit - TIP- may be requested for an additional 10 years for the same vessel as long as it is processed within 91 days prior to the permit's expiration date, by internet, through www.banjercito.com.mx/registroVehiculos/ or at any of the CIITEV centers, without the need for the vessel's inspection, plus, there is not need to submit Exit Papers.

CANCELLATION OF A TIP

If the vessel will be **DEPARTING MEXICO BY LAND**:

Vessel must be made available along with it's trailer, for inspection by Customs and Banjercito officials at the Land Port of Departure chosen to exit Mexico. The authorized individual must be present at the same time and must show the original Import Permit (TIP) and the Mobil Accessory List.

If the vessel will be **DEPARTING MEXICO BY SEA** on its own bottom:

Owner may cancel the TIP by surrendering the original and a copy of the following documents:

- Port Captain clearance
- Mobil Accessory List
- Original TIP (Temporary Import Permit)

If vessel will be leaving Mexico **AS CARGO** on a Yacht Transport Ship:

The TIP can be cancelled at the Banjercito office with the vessel's clearance documents or the cargo manifest, indicating the vessel's characteristics (name, registration or HIN).

NOTE:

The above documents may be sent via registered mail to the Banjercito Central Offices or to a Banjercito CIITEV office at any port of entry. Mexican Customs Officials will also accept the "Vessel Entrance or Clearance Statement" issued by U.S. Customs and Border Protection as proof that a vessel left Mexico and will facilitate the cancellation of the Temporary Import Permit.

INSURANCE All vessels in Mexican waters are required to show proof of valid Liability Insurance. Check your policy to make sure the vessel is covered in the areas you will be cruising and visiting.

CLEARING INTO / WITHIN / OUT OF MEXICO

CLEARING INTO MEXICO FOR THE FIRST TIME

A vessel must clear-in when entering Mexico at the first official port of entry. The clear-in process is as follows:

- Complete the Crew List Document
- Go to the immigration office and get the Crew List properly stamped and have FMMS (Forma Migratoria Multiple) issued for all passengers
- Go to the Port Captain's Office with the completed form to pay the Clear-In Fee and have the document duly authorized and stamped. In some ports you may be required to pay a Port Use Fee with the Port Administrator.

CLEARING INTO AND OUT OF PORTS WITHIN MEXICO ("CABOTAGE")

- If you are navigating from one Mexican port to another, all that you will require is that you inform the Harbor Master or marina of your arrival or departure by means of an "Aviso" [Notification].
- Depending on the Harbor Master's office, some may require a written notification, while others allow a verbal one via VHF 16
- In some ports you must pay a Port Use Fee when arriving and anchoring (if you anchor out). These fees are paid to the API (The Port Administration).

CLEARING OUT OF MEXICO

A vessel must clear-out when leaving Mexico at the last official port of exit.

IMPORTANT: You will also need your last exit paperwork when cancelling or renewing your TIP

The clear-out of Mexico process is as follows:

- Complete the Crew List for exiting Mexico ("Despacho", previously know as "Zarpe").
- Go to the Immigration office to get the Crew List stamped and surrender the FMM forms.
- Go to the Port Captain's office to pay the Vessel's Check-out fees and have the crew list stamped with the authorization to exit the country of Mexico. Boat Captain or Master must present proof of Competency for recreational boaters (example: Captains License, Sate Boating Card or International Certificate for Operators of Pleasure Craft (ICC)

IMPORTANT: Do not skip the clear-out process, since the next time you visit Mexico, your information may show that you never left the country and therefore you are considered to be in Mexico illegally.

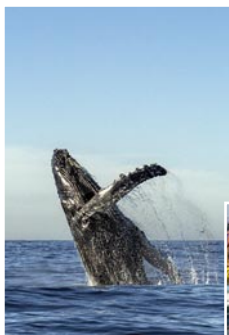
